

# LIFE MEMBERSHIP NOMINATION CRITERIA



## Nomination Criteria

The Life membership is granted to “practicing members or former practicing members of the association who are retiring from registered nursing employment.” The nominee must be completing a career as a registered nurse before the end of the nomination year to complete the licensure year or will have completed a career as a registered nurse, i.e., retired from the profession.

1. The submission must include the following information:

- Completed nomination form signed by 2 nominators, by either: 2 practicing RNs or one practicing RN and a second nominator who holds a SRNA graduate nurse, non-practicing or life membership (1 page).
- A cover letter written by 1 nominator stating reasons for nominating the individual (1 page).
- Biographical information on the candidate including their nursing education, employment, and career highlights (1-2 pages, single spaced).
- A description **of 3 of the following criteria** with examples of the individual’s outstanding service to registered nursing (2000 words or 2 pages):
  - 1) The nominee’s contribution to nursing improved the health of the people of Saskatchewan.
  - 2) The nominee’s personal contribution to nursing demonstrated competent, caring, knowledge-based nursing for the people of Saskatchewan.
  - 3) The nominee’s contribution increased the status of the nursing profession either provincially, nationally or internationally.
  - 4) The nominee contributed to the SRNA through professional activities, e.g., Council, Committee work, Chapter or Professional Practice Group membership, Workplace Representative, CNA, or workplace events or activities that promoted the SRNA to members and or the public.
- Two letters of support signed by the writers (one letter must be from a practicing SRNA member) or a letter (practicing SRNA member) and one page of supporting information such as newspaper articles, awards, research etc (2 pages).

2. Submissions must be typed and double spaced (except for biographical information and letters).
